Pre/Post-Program Submission Guidelines

Dates and Deadlines

Please make sure that your pre/post congress program starts at least 10 days after the announcement of the program online to allow time for registration!

Submission Process

Initial phase

Length 2 pages maximum

Components:

Background (3-4 sentences to describe the background info that makes your proposal significant)

Educational Program Objective (in bullet form)

Methods (describe the program structure, duration, how often learners meet, identified learners, teaching methodology/ tools including online tools)

Evaluation process (how learning objectives will be measured)

Mentors/ supervisors or co-educators (short bios)

Significance & Impact (in bullet form)

Category (choose one)

Certificate/ Continuing education credits (Yes (describe)/ No)

Phase I Scoring

- Review will use a 1 to 10 Likert scale for each of the following categories:
 1. The pre/post congress program submission is linked to the prenatal sciences
 2. The proposal is linked to at least one of the congress themes
 3. Importance of the topic
 4. Potential impact on learners
 5. Innovation
 6. Feasibility
 7. Quality of methods
 8. Evidence and quality of evaluation
 9. Potential to influence education beyond this congress, or deepen understanding
 10. It supports at least one community (service users, health professionals, researchers, stakeholders, policy makers, educators, academics)
- Maximum possible score is 100
- The educational board will provide comments to each applicant and will include strengths of the proposal and constructive feedback for improvement.

Final phase (completion of the proposal)

Components:

Title page with title and main message

Full abstract

Background/ needs assessment

Goals & Objectives (narrative form)

Impact

Max 2-page outline of learning plan for developing 1. Knowledge and understanding, 2. Professional/ personal skills

Timetable and plan for dissemination of the info re to the program and its process/ final conclusions

Bibliography

Full curriculum vitae of applicant or biosketches for other contributors

Video presentation of each educator/ mentor (self presentation and program)

20 messages to be used on social media (text/ images/ audio/ video)

Signed consent for videorecording of the program

Signed agreement for transfer of rights of the program to the organizers

Fee suggested to be paid to the educator(s)

Minimum number of participants
